The following are the instructions to the candidates provisionally shortlisted for counseling.

- I. The candidates are informed to report for counseling on the prescribed date sharp at 08.00 AM at the RGUKT RK Valley(Idupulapaya) Campus allotted to them, along with the **original documents /certificates** mentioned below, without fail. It is their responsibility to make all suitable travel arrangements so as to reach the RGUKT RK Valley(Idupulapaya) Campus, Vempalli, Kadapa district allotted by 8.00 AM on the above date.

**Admission shall not be given if they fail to attend the counseling in person on the above date and time for whatever reason.** The seat will be allocated to the next best candidate from the waiting list, immediately.

- II. **Mere selection for counseling does not guarantee admission.** Admission will be given only if he/she fulfills all the eligibility criteria and pay relevant fee after the verification of original certificates / documents. **His/her selection stands cancelled in case if he/she fails to produce the original certificates mentioned below at the time of verification or fail to pay the requisite fee.**

- III. Documents to be brought:

The candidates shall bring the following documents /certificates in **original** along with **three** sets of their Xerox copies.

1. Hall Ticket of 10<sup>th</sup> Class Board Examination
2. Grades Sheet of 10<sup>th</sup> Class Board Examination
3. SSC Transfer Certificate and Conduct Certificate. However in the event of already taken admission elsewhere, the candidate can be given time to produce original TC within two days by giving an undertaking to that effect, and otherwise the admission will be cancelled .
4. Study certificates **(from 4<sup>th</sup> to 10<sup>th</sup> Class)**
5. Candidates selected under Non-local Category have to submit a Residence Certificate as a proof to effect that the candidate have resided in the state for a total period of 10 years excluding periods of study outside the state or either of whose parents have resided in the state for a total period of 10 years excluding period of employment outside the state.
6. Caste/Community certificate issued by the competent authority **(Meeseva Only)**
7. Income Certificate / Salary Certificate (latest issued from Meeseva Only).
8. Latest four photographs each of the candidate and parent

9. Ration Card
10. Aadhar Card of the candidate and Parents
11. The candidates who wish to avail bank loan shall bring the following (The loan applications will be available at the bank on the campus):
  - a. Additional four sets of copies of the above certificates
  - b. Employee Identity Card
  - c. Salary Certificate (Latest)
  - d. PAN card of Student & Parent
  - e. Ration Card / PAN Card / Voter Id Card /Aadhar Card
  - f. Six photographs of the candidate and four photographs of the Parent/Guardian

IV. The admitted students have to attend in person, they have to register for the courses and classes will start on 25<sup>th</sup> July 2016. Late registration is not permitted. The admitted candidates should be prepared to stay for the entire first term from that date.

V. Fee to be paid:

If selected, the tuition fee for candidates who studied in Schools in AP & TS is Rs.36,000/- (Rupees Thirty Six Thousand only) which is to be paid through the mode of Demand Draft favoring, Director, RGUKT Idupulapaya and payable at SBH Idupulapaya from any nationalized bank. DD shall be paid at the campus allotted on the day of counseling. Students who are eligible for tuition fee reimbursement need not pay the tuition fee (students whose parental annual income is below Rs.1.0 lakh for non SC/ST category and below Rs.2.0 Lakh for SC/ST category and who fulfill the other conditions as per the latest Govt. Rules are eligible for fee reimbursement)

However, every student has to pay a registration fee of Rs.1,000/- (Rs.500 for SC/ST students) and a refundable caution deposit of Rs. 2,000/- at the time of admission, that is a total of Rs.3,000/- (Rs.2,500/- for SC/ST students)
