- 5.4. Bidder should furnish satisfactory Performance Certificate from the parties concerned to whom bulk supplies were made and RGUKT may contact any such parties to elicit details.
- 5.5. Bidder should be a Registered Vendor under GST Act with the relevant authorities and shall furnish the copies of GST registration document, PAN and TAN copies along with the bid document.
- 5.6. - 8.2 The technical bids will be evaluated so as to ascertain the capabilities of the bidders to provide the material within the stipulated period and also to assess whether the bidder satisfies the eligibility criteria.
- 8.3 The rejection of the bidder on technical grounds will be based on the failure to meet eligibility requirements.
- Also the bidder has to produce samples of each item (one samples each) at the time of submission of hard copy of technical bid documents. The samples will be inspected by the Members of the Committee for conformance of the specifications. The Committee may reject a bid for non-conformance of the specifications of the material. - 11.4. There shall be a warranty period of 06months and within the warranty period, in case of any damage to the supplied material like breakage, wear and tear, mechanical defects, discoloring etc it will be the responsibility of the supplier to replace the damaged material with a new one.
- 11.5 It is also the responsibility of suppliers to attend to alteration/ repairs of the items supplied of Maximum 10% of the quantity if the alterations/ repairs are beyond this limit, the entire lot will be rejected.
- 11.6 Any alteration to the uniform will be the responsibility of the supplier

12. DISPUTES:
